Jonie Paye, LoisGrace Golde, and Michael Raymaker are stepping down from the Board after completing their terms.

Paye served 9 years as a director, including chairing the board for two years from 2016 to 2018. She recently served as chair of the 25th Anniversary Task Force in 2021 and is entering her second year as chair of the Garden's Membership Committee. As committee chair, Paye will stay on as a board advisor. Golde completed a three-year term and served on the Finance Committee while Raymaker completed two three-year terms, was Board Chair from 2013 to 2014, and served on the Garden's Finance and Endowment committees.

Returning for her final three-year term is Laura Nelson, M.D., and returning for their second three-year terms are Murphy O'Hearn and Nicole Polarek.
